**RE: MOHELA Practices May Violate Federal Consumer Financial Laws**

Dear Chair Gruenberg:

We are writing to alert you to practices by the Missouri Higher Education Loan Authority (MOHELA) that appear to violate federal consumer financial laws.

MOHELA has a long history of improper and unlawful business practices that routinely harm millions of its customers.<sup>1</sup> Amid mounting concerns about misinformation on MOHELA's website and potential liability for these abuses, it appears that MOHELA is now disclaiming the "quality" and "accuracy" of the information on its website and is forcing its customers to agree to an illegal and unenforceable waiver of liability and waiver of legal remedies otherwise available to its customers under federal and state law.<sup>2</sup>

Student loan borrowers do not get to choose MOHELA as their loan servicer; they are required by the owner of their student loan to make payments and obtain account information through MOHELA's websites. Nevertheless, MOHELA presses these customers into waiving their rights. For example, millions of borrowers with federal student loans are presented with an expansive waiver when they access their student loan accounts at [mohela.studentaid.gov](https://mohela.studentaid.gov) (Appendix A).<sup>3</sup> MOHELA customers with private student loans made by banks like KeyBank (d/b/a Laurel Road) and SoFi are presented with a similar waiver (Appendix B).<sup>4</sup> MOHELA's customers are told:

By entering or using of this website, you confirm that you have read and understand these Terms and agree to be bound by them. MOHELA requires all visitors to our website to

agree and adhere to these Terms, without modification or limitation. If you do not agree to these Terms, you are not authorized to access or use this website.<sup>5</sup>

While the existence of this waiver is cause for alarm, the substance of the waiver is even more disturbing. MOHELA, which is paid hundreds of millions of dollars to advise borrowers about repayment options, collect monthly payments, and manage loan accounts, warns its customers that the company will not:

WARRANTY OR GUARANTY THAT THE WEBSITE OR THE CONTENT OF THIS WEBSITE IS ERROR FREE OR... WILL BE ACCURATE OR RELIABLE...<sup>6</sup>  
(capitalization original)

Earlier this year, AFT filed a lawsuit against MOHELA for a wide range of unlawful practices related to its handling of federal student loans owned by the U.S. Department of Education. These allegations include claims that MOHELA unfairly and deceptively provided borrowers with inaccurate information on its website, in violation of the District of Columbia's state consumer protection law.<sup>7</sup> Taken in this context, MOHELA's waiver would suggest the financial services firm has abandoned any duty of care owed to its customers and it is unwilling or unable to perform its most basic obligations to the holders of the loans it services.

MOHELA's waiver also appears to be a clumsy and potentially illegal effort to suppress efforts by borrowers to hold MOHELA accountable for its abuses. For example, MOHELA's customers with federal student loans are required to:

[AGREE] THAT, TO THE FULLEST EXTENT PERMITTED BY LAW, MOHELA ... SHALL NOT BE LIABLE TO THE USER OR ANY THIRD PARTY FOR ANY LOSS OF PROFITS, LOSS OF USE, INTERRUPTION OF BUSINESS, OR ANY INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND ARISING OUT OF OR IN CONNECTION WITH YOUR USE OF, OR INABILITY TO USE, THE WEBSITE OR ANY CONTENT ON THE WEBSITE, EVEN IF MOHELA WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR WAS GROSSLY NEGLIGENT.<sup>8</sup> (capitalization original)

In addition to this general waiver of rights, MOHELA also imposes a specific waiver of remedies and a statute of limitations for legal action on its customers—attempting to bar actions brought after more than one year and limiting damages to just \$100.<sup>9</sup>

The Bureau has called attention to unlawful conduct by market participants that force customers to waive rights guaranteed under federal consumer financial laws. For example, in 2023, the Bureau brought an enforcement action against Chime (d/b/a Sendwave) for “wrongly requiring consumers to waive their rights,<sup>10</sup> including their rights to privately enforce the Electronic Funds Transfer Act (EFTA).<sup>11</sup> In this matter, the Bureau found that Chime’s effort to compel its customers to waive their legal rights and remedies under EFTA violated both EFTA and the Consumer Financial Protection Act.<sup>12</sup> MOHELA’s conduct is similar in its effect and may also violate both laws.

This letter only addresses MOHELA’s potential unlawful practices with respect to the consumer financial laws enforced by the Bureau. This conduct also raises serious questions about whether it is lawful, appropriate, or consistent with MOHELA’s federal contract for it to require users of a website co-branded with the U.S. Department of Education’s Office of Federal Student Aid to waive their rights and remedies in this manner on a federal government website (mohela.studentaid.gov).<sup>13</sup>

This is corporate misbehavior at its worst. It is important for regulators to consider the abuses cited in this letter in the context of MOHELA’s heinous track record as a loan servicer. MOHELA routinely refuses to properly service borrowers.<sup>14</sup> It uses its position of power to bully

critics who call it out.<sup>15</sup> It fights to dismiss consumer protection lawsuits, arguing that it is above the law.<sup>16</sup> Now it uses deception to lure borrowers into waiving rights protected under federal and state law.

Millions of borrowers depend on MOHELA for accurate, timely, and actionable information about their private and federal student loans. We urge you to take immediate action to protect borrowers' rights under the law and halt MOHELA's unlawful use of this waiver.
